# **Too Many Illinois Families are Struggling with Debt**



**1 in 3 Illinois residents** have a credit card, medical or utility bill that is 180 days past due, and are now in the **debt collection process**.



About **40% of Illinois households** are considered **liquid asset poor**, meaning they lack sufficient savings to live above the federal poverty level for at least three months if they experience a significant disruption in their income.



**Garnishment for consumer debt is on the rise**. Working-class individuals and families in the Midwest, especially those in the manufacturing sector, face the highest rates of wage garnishment in the nation.

Exemption laws are intended to prevent creditors from pushing consumers and their families into poverty. Illinois law misses the mark.

### **HB2584 Will:**

- Protect a larger percentage of a worker's wages from garnishment allowing workers to provide for their families while paying down their debt.
- **Protect a portion of a family's savings** allowing them access to the minimal funds needed to stay housed, continue to work, and meet the basic needs of their family.
- Exempt college savings accounts from the debt collection process.
- Creates a clearer wage assignment notice guaranteeing that all workers know their rights.
